NOTICE IS HEREBY GIVEN that a hearing will be held before the Florida Public Service Commission in the above docket regarding the petition to determine need for Florida Energysecure Pipeline by Florida Power & Light Company.

Additional days will be allocated for the continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

Members of the public will be given the opportunity to present testimony at the beginning of the hearing on Tuesday, June 16, 2009.

Members of the public wishing to testify are urged to be present at the beginning of the hearing, since the hearing may be adjourned early. By providing testimony, members of the public do not become a party to the proceeding. To become an official party of record, you must file a Petition for Intervention at least five days before the final hearing, pursuant to the requirements contained in Rule 25-22.039, Florida Administrative Code.

PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the petition of Florida EnergySecure Pipeline by Florida Power & Light Company to determine need for an intrastate natural gas transmission pipeline and any motions or other matters that may be pending at the time of hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement. Any person requiring some accommodation at this hearing because of a physical impairment should call the Office of Commission Clerk at (850) 413-6770 at least 48 hours prior to the hearing. Any person who is hearing or speech impaired should contact the Florida Public Service Commission by using the Florida Relay Service, which can be reached at 1-800-955-8771 (TDD).

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on June 5, 2009. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

The purpose of this prehearing conference is: (1) to define and limit, if possible, the number of issues; (2) to determine the parties' positions and the issues; (3) to determine what facts, if any, may be stipulated; (4) to dispose of any motions or other matters that may be pending; and (5) to consider any other matters that may aid in the disposition of this case.

EMERGENCY CANCELLATION OF HEARING

If settlement of the case or a named storm or other disaster requires cancellation of the hearing, Commission staff will attempt to give timely direct notice to the parties. JURISDICTION

Jurisdiction over this utility is vested in the Commission by Chapters 366 and 368, Florida Statutes; authority to determine the need for the gas transmission pipeline is governed by Section 403.9422, Florida Statutes.
