Mr. Bassett and Ms. Bonner,

I am the Analyst working up your CLEC application. I would like you to expand on question 18(c), page 6 of the application. We recognize you do not have financial statements, but we do want you to send a few paragraphs explaining how you will be funded to operate a CLEC in Florida. If you are self funded, then explain that and explain how much money is dedicated to the startup operations. If you have projected plans, explain them.

There is no criteria of financial capability, however, funding sources should be discussed with more detail even without financial statements and signed as 'true and correct' by you both as officers. Do you have a business bank account, if so, a faxed bank statement is good to have in the file, just black out the account number since it will become part of the public record.
