O & S Water Company will continue to send annual reminders to customers who have backflow prevention devices, along with a list of plumbing technicians who are certified in backflow inspection.

The Commission authorizes the Utility to discontinue service, after five days written notice, to any customer with a backflow prevention device that fails to provide documentation of an annual inspection.
