Dear Ms. Cole:

USD CLEC, Inc. ("USD"), by its attorneys, respectfully requests that the Florida Public Service Commission ("Commission") cancel its authorization to provide intrastate telecommunications services in Florida and any associated tariffs. USD has no customers in Florida at this time, so no customers will be affected by this cancellation. It is USD's understanding that no formal approval is required from the Commission to surrender its authorization and associated tariffs. However, should the Commission determine that approval is required, USD respectfully requests that the Commission approve the cancellation of its authority as discussed herein.

USD, a corporation incorporated under the laws of New York, currently is located at 318 South Clinton, 3rd Floor, Syracuse, New York 13202 (315) 579-7000. USD previously provided hosted IP communication services, audio conferencing services, nationwide integrated VoIP PRI, COM dedicated Internet services, IP termination-origination services and collocation services. On ECR October 3, 2008, USD and affiliated entities filed voluntary petitions for bankruptcy with the GCL -U.S. Bankruptcy Court for the Northern District of New York pursuant to Chapter 11 of the U.S. OPC Bankruptcy Code (See Case Nos. 08-32560 to 32562). On March 11, 2009, the Bankruptcy Court approved the sale of certain of the USD assets to Warwick Valley Mobile Telephone RCP Company ("Warwick"). The sale of assets was consummated on April 24, 2009. Thus, USD is SSC no longer providing service and does not hold any telecommunications assets. **SGA**

In Florida, although USD currently holds an authorization to provide intrastate telecommunications services granted by the Commission on June 8, 2006, the services USD provided in Florida prior to the sale of assets were not regulated by the Commission. Now, any former USD assets and customers that received unregulated service from USD have been transferred to Warwick. Thus, with this letter, USD respectfully requests the cancellation of its telecommunications authorization and any associated tariffs. Because USD has no customers, no customer notification letter of discontinuance is required.
