#### PURPOSE AND PROCEDURE

The purpose of this hearing is to receive testimony and exhibits and to take final action relative to the Commission's review of the utilities' numeric conservation goals and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on August 3, 2009. All witnesses shall be subject to cross-examination at the conclusion of their testimony.

#### PURPOSE

The purpose of this prehearing conference is: (1) to define and limit, if possible, the number of issues; (2) to determine the parties' positions on the issues; (3) to determine what

facts, if any, may be stipulated; (4) to dispose of any motions or other matters that may be pending; and (5) to consider any other matters that may aid in the disposition of this case.
