Pursuant to Rule 25-30.120(7)(a)2., F.A.C., St. John's continues to be responsible for paying interest of one percent every thirty days on the unpaid balance of the regulatory assessment fees. The amounts shown above have been calculated as of August 30, 2009.

The interest amount changes after August 30, 2009, and increases over time. Any delay in payment past August 30, 2009, will subject St. John's to additional interest. In addition, if payment in the above listed amount is not received by the stated due date, the Commission may initiate show cause proceedings. If show cause proceedings are initiated, and the utility is found to be in violation of Commission rules, pursuant to Section 367.161, Florida Statutes, the Commission is authorized to impose fines of up to \$5,000 for each day the violation continues.
