PROGRESS ENERGY FLORIDA, INC.'S NOTICE OF ADOPTION OF JEFFREY LYASH'S MARCH 20, 2009 TESTIMONY BY VINCENT DOLAN

Progress Energy Florida, Inc. ("PEF" or "Company") files this Notice of Adoption of Portions of Jeffrey Lyash's March 20, 2009 Testimony by Vincent Dolan ("Notice of Adoption") and states:

1. On March 20, 2009, Jeffrey Lyash submitted pre-filed direct testimony supporting the Company's petition for an increase in rates. At that time, Mr. Lyash was CEO/President of PEF.

2. Mr. Lyash, effective July 6, 2009, is no longer the CEO/President of PEF; he is now the Executive Vice President for Corporate Development for Progress Energy. Mr. Dolan is now the CEO/President of PEF.

3. Mr. Dolan will be adopting Mr. Lyash's March 20, 2009 direct testimony in its entirety. Mr. Dolan will also be filing Rebuttal Testimony in this docket. PEF will file with the Commission fifteen (15) copies, plus the original, of Mr. Dolan's Rebuttal Testimony, which sets forth his background and experience.
