



2           **CHAIRMAN CARTER:** Staff, you're recognized  
3 for Item 3.

4           **MS. MILLER:** Commissioners, Cindy Miller  
5 with the Office of General Counsel.

6           This is Item 3. At the August 18th  
7 agenda, Issue 2 of Docket 080641 was deferred until  
8 this agenda, and the item relates to the preferred  
9 carrier or PC freeze rule, Rule 4.083. This item  
10 has been noticed for Commissioner and staff  
11 participation only, and we recommend that the  
12 Commission adopt as final the rule that was  
13 previously proposed.

14           **CHAIRMAN CARTER:** Thank you.  
15 Commissioners, any discussion? Any questions? Any  
16 concerns?

17           **COMMISSIONER EDGAR:** Mr. Chairman, I guess  
18 I just would point out that --

19           **CHAIRMAN CARTER:** You're recognized,

21           **COMMISSIONER EDGAR:** Thank you, Mr.  
22 Chairman. That this item obviously has been a long  
23 process. We have taken up pieces and parts of it at  
24 different times after hearing clearly today, since  
25 it is post-hearing, participation is limited to

1 Commissioners and staff. My understanding is that  
2 this has been, you know, a long work in progress,  
3 and it probably involves some compromises and some  
4 consensus, but with that in mind I am comfortable  
5 with the item as it is presented before us.

6 **CHAIRMAN CARTER:** Commissioners?

7 I want to thank our staff for their hard  
8 work in putting this together and working with the  
9 parties on that. I mean, they've done a lot of  
10 heavy lifting on this.

11 And, Commissioners, I want to thank you,  
12 too, for your deliberation on this matter. With  
13 that, the Chair is now open for a motion.

14 **COMMISSIONER EDGAR:** Mr. Chairman.

15 **CHAIRMAN CARTER:** Commissioner Edgar,  
16 you're recognized.

17 **COMMISSIONER EDGAR:** Thank you. I offer a  
18 motion in favor of the staff recommendation for all  
19 issues in Item 3.

20 **COMMISSIONER SKOP:** Second.

21 **CHAIRMAN CARTER:** It has been moved and  
22 properly seconded.
