ISSUE 3: What are the total purchased gas adjustment amounts to be collected during the period January 2010 through December 2010?

PGS: \$2,121,675 overrecovery

ISSUE 4: What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2010 through December 2010?

<u>PGS</u>: \$1.19468 per therm

<u>ISSUE 5</u>: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

<u>PGS</u>: The charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2010 through December 2010. Billing cycles may start before January 1, 2010, and the last cycle may be read after December 31, 2010, so that each customer is billed for twelve months regardless of when the adjustment charge became effective.
