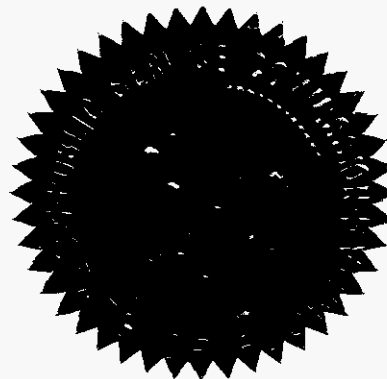

2           **CHAIRMAN CARTER:** Let's prepare now,  
3 Commissioners, as we allow staff to get together for  
4 Item 6. Item 6. And just FYI, Commissioners, after  
5 we finish Item 6, there is going to be a 6A. And we  
6 will have staff to tee that up, but we will go to 6A  
7 before we go to 7. Okay.

8           Staff, you're recognized.

9           **MR. ELLIS:** Good morning, Commissioners.

10           I'm Phillip Ellis with Commission staff.  
11 Commissioners, Item 6 is a petition from Progress  
12 Energy Florida requesting approval of its 2009  
13 standard offer contract. The petition updates the  
14 avoided unit and includes an availability typical  
15 for the life of the avoided unit of 94 percent. It  
16 also removes the right of first refusal for tradable  
17 renewable energy credits. Staff believes the  
18 proposed standard offer is in compliance with the  
19 Commission's rules and recommends approval of  
20 Progress' modifications to its renewable energy  
21 tariff.

22           Staff is available to answer any questions  
23 you may have. Thank you, Mr. Chairman.

24           **CHAIRMAN CARTER:** Thank you.

25           Commissioners, any questions?

1 Commissioner Skop, you're recognized for questions.

2 **COMMISSIONER SKOP:** Thank you, Mr.  
3 Chairman. Just the same comment as I had before  
4 with respect to -- I respect the majority's decision  
5 to amend the contract to remove the right of first  
6 refusal; but, again, my position would be that that  
7 might make sense ultimately. So I just wanted to  
8 reiterate my previous comment.

9 **CHAIRMAN CARTER:** Okay. Commissioners,  
10 anything further? Hearing none, the Chair is now  
11 opening for disposition of this matter.

12 **COMMISSIONER EDGAR:** Mr. Chairman, I move  
13 adoption of the staff recommendation on both issues.

14 **COMMISSIONER SKOP:** Second.

15 **CHAIRMAN CARTER:** Commissioners, it has  
16 been moved and properly seconded. Any further  
17 discussion? Any debate?

18 Hearing none, all in favor, let it be  
19 known by the sign of aye.
