



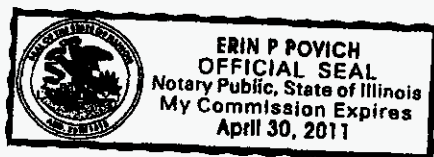

CUSTOMER NOTICE

ISSUED: NOVEMBER 11, 2009

On December 4, 2008, Labrador Utilities, Inc. (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested a permanent rate increase of 94.0% for water service and 50.0% for wastewater service.

By Proposed Agency Action Order No. PSC-09-0462-PAA-WS ("PAA Order"), issued June 22, 2009, the Commission proposed a rate increase of 65.0% for water service and 37.3% for wastewater service. The PAA Order was protested within the protest period by the Office of Public Counsel ("OPC"). After negotiations between the Utility, OPC and PSC Staff, the parties agreed to a final rate increase of 62.8% for water service and 26.9% for wastewater service. The Commission approved these rates by its Final Order No. PSC-09-0711-AS-WS, issued October 26, 2009. These rates were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service.

The increased rates and charges are effective for service on or after November 16, 2009.

The rates prior to filing and the Commission-approved water and wastewater rates are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
