On December 28, 2009, Verizon Florida LLC (Verizon) filed a petition for variance from Rules 25-4.0185 and 25-4.073, Florida Administrative Code (F.A.C.). On October 2, 2009, the Florida Public Service Commission (Commission) issued Order No. PSC-09-0660-FOF-TP¹ noticing the adoption with changes of amendments to its service quality rules. Of significance in these changes is that, effective October 21, 2009, the service quality rules would apply to residential basic local telecommunications service customers only, not all residential lines.
