Martha,

This will respond to your recent telephone inquiry regarding the status of Docket No. 090146-EI, which has been in suspension/deferral upon request of the Commission.

Specifically, you asked whether the City of Tampa and TECO could reasonably be expected to submit for consideration at the Commission's March 16th Agenda Conference a renegotiated form of the December, 2008 "extension of small power production agreement" between the City and TECO.

Unfortunately, the answer to that question is no, as will be explained in more detail below.

I am advised that the proposed changes to the extension that was submitted to the Commission for approval in March, 2009 - will require prior approval of the Tampa City Council. Before a renegotiated extension could be placed on the City Council's schedule, would first be required, among other things, to successfully complete an internal review by various City departments.

I am further advised that under the best possible scenario, the earliest date by which a renegotiated extension could be placed on the City Council's schedule for consideration would be March 18th or April 1st. This best possible scenario assumes an acceptable renegotiation with TECO followed by the favorable completion of the internal review at least one week prior to the City Council meeting.

I have endeavored to be, and trust that this is, fully responsive to your inquiry.
