Per the Staff's instructions on the March 24, 2010 Status Call, FCTA submits the following questions to AT&T and CompSouth to assist in understanding of the bilateral agreement between certain CompSouth members and AT&T in this docket, filed with the Commission on March 23, 2010:

- 1) AT&T and CompSouth stated on the March 24, 2010 conference call with Staff that their agreement embodied all of the agreements made by all parties through the workshop process. Please provide us with a matrix that shows the areas of agreement you believe were reached as of the final day of the December 16, 2009 Commission workshop.
- 2) What are the benefits to a) AT&T; b) CompSouth, and c) the State of Florida that would result from doing away with Tier II penalties?
- 3) What is the rationale for doing away with Tier II? What is the rationale for increasing penalties for Tier I by 20 percent?
