3	Q.	DID YOU MAKE ANY FURTHER ATTEMPTS TO CONTACT EAST
4		MARION SANITARY SYSTEMS, INC.?
5	A.	No, I felt it was useless and I had heard from other residents in the community
6		about the Company's plans to the inflate the charge for an irrigation meter.
7		
8	Q.	HAVE YOU RECEIVED ANY LETTERS FROM EAST MARION
9		SANITARY SYSTEMS, INC.?
10	A.	Yes, only in regards to a drastic increase in the cost for installation of meters and
11		other cost increases.

13	Q.	DO YOU KNOW BEA JORDAN?
14	A.	Yes.

16	Q.	IS MISS JORDAN AN EMPLOYEE FOR EAST MARION SANITARY
17		SYSTEMS?
