MISCELLANEOUS SERVICE CHARGES

The company may charge the following miscellaneous service charges in accordance with the terms stated herein. If both water and wastewater services are provided, only a single charge is appropriate unless circumstances beyond the control of the Company requires multiple actions.

<u>INITIAL CONNECTION</u> — This charge may be levied for service initiation at a location where service did not exist previously.

<u>NORMAL RECONNECTION</u> — This charge may be levied for transfer of service to a new Customer account at a previously served location or reconnection of service subsequent to a Customer requested disconnection.

<u>VIOLATION RECONNECTION</u>—This charge may be levied prior to a reconnection of an existing Customer after disconnection of service for cause according to Rule 25-30.320(2), Florida Administrative Code, including a delinquency in bill payment.

<u>PREMISES VISIT-</u> This charge is to be levied when a service representative visits a premises at a customer's request for complaint resolution and the problem is found to be the customer's responsibility.

<u>PREMISES VISIT CHARGE IN LIEU OF DISCONNECTION</u>—This charge may be levied when a service representative visits a premises for the purpose of discontinuing service for nonpayment of a due and collectible bill and does not discontinue service because the customer pays the service representative or otherwise makes satisfactory arrangements to pay the bill.

<u>DELINQUENT PAYMENT CHARGE</u> – This charge will be assessed to customer's invoices when payment is made after the 21st day of the invoice date. (Rule 25-30.335(4) F.A.C.)

<u>METER TAMPERING CHARGES</u> – Will be assessed to customer's invoice when a service representative makes a premises visit to validate meter tampering on a disconnected meter. In addition, actual cost will be assessed to customer for any necessary repairs.
