Re: Aqua Utilities Florida, Inc. - Request for Test Year Approval Pursuant to

Rule 25-30.430, Florida Administrative Code

Dear Chairman Argenziano:

Aqua Utilities Florida ("AUF" or "Company") intends to submit an application for general rate relief to the Florida Public Service Commission ("Commission") for its water and wastewater systems in Alachua, Brevard, DeSoto, Hardee, Highlands, Lake, Lee, Marion, Orange, Palm, Beach, Pasco, Polk, Putnam, Seminole, Sumter, Volusia and Washington Counties. AUF will not be seeking rate relief for its Chuluota water or wastewater systems as part of this application. AUF intends to file its application including the minimum filing requirements (MFRs) on or before September 1, 2010.

The need for rate relief is largely driven by two factors that have arisen since AUF's last rate case which was based on an historic test year ending 2007. First, AUF has made substantial capital investment in plant and equipment to improve the quality of water and wastewater service and address issues raised by customers. The capital improvements made since the last rate case total approximately \$8.4 million and include, but are not limited to, tank rehabilitation and replacement, meter replacement, electrical upgrades, pump replacements, and improvements to treatment systems.

AUF considers customer satisfaction and water quality its top priorities and, to that end, as taken substantial steps to address secondary (aesthetic) water quality standards. The Company intends to propose pro forma plant additions that address environmental compliance requirements, as well as the aesthetic issues, which will include repairs to and replacements of water and wastewater facilities. These pro forma additions will be detailed in the MFRs, which will also include pro forma adjustments for health insurance expense, purchased water, and other

costs. These pro forma adjustments, which are preliminarily identified in Attachments A and B hereto, are not growth-related and include both capital and expense items. AUF will provide fully supported documentation for review as the rate case is processed.

The second factor that drives the need for rate relief is that consumption has plummeted by nearly 16 percent from the Commission's consumption calculations in the last rate case. This reduction in consumption has resulted in corresponding reductions in revenues. The drop in consumption and corresponding reductions in revenues are significant and are directly attributable to the installation of a large number of private irrigation wells. (For example, 136 private irrigation wells have been installed to date in one of the Company's systems.) As a result, AUF's water volume sales are not producing revenues sufficient to cover the costs that the Commission determined were reasonable in the last rate case. The Company's 2010 ROE is projected to be one percent (1%) or 8 basis points below the Commission established 9.75% midpoint. At this earnings level the Company cannot realistically maintain a stable financial position and, without rate relief, will not be in a position to meet its customers' needs for safe and reliable water and wastewater services.

The decision to seek rate relief at this time is not one that the Company has taken lightly. Indeed the Company has made all reasonable effort to avoid filing a rate case. However, AUF's current revenues are simply insufficient to continue to meet its utility responsibilities in the manner that the Commission and AUF's customers expect. With the Company's current consumption and sales forecasts, and the costs it must incur to provide safe and reliable water and wastewater services, the Company's return on equity will fall to a negative return without the requested rate relief. This negative return on equity is well below the return established by the Commission's leverage formula and is far below the returns that the Commission has awarded to other water and wastewater utilities. Faced with these dire conditions, the Company has no choice but to seek timely rate relief.

To minimize rate case expense and mitigate rate impact, AUF requests that this case be processed using the proposed agency action ("PAA") procedures set forth in Section 367.081(8), Florida Statutes. These PAA procedures provide a cost-effective mechanism through which the Commission and its staff can thoroughly address all of the customers' and the Company's issues related to the rate case. AUF's customers will have ample opportunity to voice any concerns they may have at customer meetings held throughout AUF's service territory. AUF respectfully submits that utilizing the PAA process will minimize rate case expense and result in lower rates for the customer.

Finally, as part of its request for rate relief and pursuant to Rule 25-30.430, Florida Administrative Code, AUF requests approval of a historic test year ending April 30, 2010. The requested test year is representative of a normal full year of operation and will best fulfill the purpose of a test year, which is to set rates based on costs and revenues that are representative of the period when new rates will be in effect. AUF has not experienced any significant changes in its operations since April 30, 2010, and does not anticipate any such changes prospectively. The Company will also request interim rates based on the same historic test year and , as indicated above, intends to submit the MFRs on or before September 1, 2010.
