
Dear Chairman Argenziano:

Yesterday we filed a letter requesting test year approval on behalf of Aqua Utilities Florida, Inc. ("AUF"). That letter contains a typographical error that we would respectfully ask be corrected. Specifically, the next to the last sentence of the first full paragraph on page two of the letter (which makes reference to AUF's projected ROE for 2010) should be corrected to read: "The Company's 2010 ROE is projected to be one percent (1%) or 800 basis points below the Commission established 9.75% midpoint." The balance of the letter remains unchanged.
