REQUEST FOR CONFIDENTIAL TREATMENT

Florida Public Utilities Company ("FPUC" or "Company"), by and through its undersigned attorneys, pursuant to Section 366.093, Florida Statutes, and in accordance with Rule 25-22.006(4), Florida Administrative Code, hereby submits this request for confidential classification of certain information provided to the Commission in response to Mr. Timothy J. Devlin's letter dated June 1, 2010. In support thereof, FPUC states:

1. Subsection 366.093(1), Florida Statutes, provides that upon request, records received by the Commission which are "found by the commission to be proprietary confidential business information shall be kept confidential and shall be exempt from s. 119.07(1)."

2. "Proprietary confidential business information" is defined as "information, regardless of form or characteristics, which is owned or controlled by the ... company, is intended to be and is treated by the ... company as private in that the disclosure of the information would cause harm to the ratepayers or the company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public." Section 366.093(3), Florida Statutes.

3. Proprietary confidential business information includes, but is not limited to, information concerning:

(b) Internal auditing controls and reports of internal auditors.

(c) Security measures, systems, or procedures.

(d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms.

(e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information.

(f) Employee personnel information unrelated to compensation, duties, qualifications, or responsibilities.

Section 366.093(3), Florida Statutes.

4. The specific confidential information being provided to the Commission in FPUC's Response to Mr. Devlin's letter falls within these statutory definitions, and therefore constitutes proprietary confidential business information entitled to protection under Section 366.093 and Rule 25-22.006.

5. The highlighted, confidential information provided in response to the Commission's request for information is treated by the Company as highly confidential information, the disclosure of which could have significant impacts directly upon the Company's ability to compete for services, as well as its ability to retain qualified employees while protecting employee morale.

6. Specifically, FPUC seeks confidential treatment of the highlighted numbers set forth on pages 1, 2, and 3 of its Response to Mr. Devlin. These amounts reflect either salary

amounts associated with the specified employee, or they represent amounts paid to outside legal counsel and consultants for various services.

7. With regard to the amounts associated with the specified employee, as set forth in FPUC's response to Question 1 (Page 1), the Company maintains salary information as strictly confidential information in an effort to prevent other entities from raiding FPUC for its highly qualified, skilled employees. The Company also protects this information to preserve morale among employees, and believes that disclosure of such information could result in difficulties and potential inefficiencies associated with reduced employee satisfaction and lowered morale. As such, the information, if disclosed, could impair FPUC's competitive interests by impacting its ability to retain qualified employees, and by harming its operations if employee morale is adversely impacted.

8. Similarly, the highlighted numbers set forth in response to Question 3 (Pages 2 and 3) reflect amounts paid to outside counsel and consultants during the period in question. The amounts indicated are monies paid pursuant to negotiated contracts for services, and if disclosed, could impair FPUC's ability to contract for such outside services on favorable terms as compared with other similarly situated companies, thus also impairing FPUC's competitive interests. FPUC treats this information as confidential, and has not otherwise disclosed these amounts publicly.

9. Along with this request, FPUC is submitting one highlighted, and two redacted copies of its Response to Mr. Devlin, in accordance with Rule 25-22.006(4), Florida Administrative Code. Pursuant to Section 366.093(4), Florida Statutes, and Rule 25-22.006(9), Florida Administrative Code, FPUC requests that the information described above as proprietary (TL230362;1)

confidential business information be protected from disclosure for a period of at least 18 months and asks that all information be returned to the Company as soon as the information is no longer necessary for the Commission to conduct its business.
