JOINT PETITION FOR WAIVER

Pursuant to Rule 25-24.455(4), Global Crossing Telemanagement, Inc. ("GCTM") and Global Crossing Local Services, Inc ("GCLS") (together, "Petitioners") respectfully request that the Florida Public Service Commission ("Commission") waive Florida Administrative Code rule 25-24.118, in order to facilitate the transfer of customers from GCTM to GCLS, as part of an internal corporate reorganization whereby GCTM will be merged into GCLS.

Following approval of this waiver request, GCTM will transfer approximately 81 business accounts in Florida to GCLS on or about September 30, 2010. Written notice of the proposed merger will be provided to GCTM customers on or about July 31, 2010. The customer notification will advise customers of the following: (1) the pending change of their local carrier selection to GCLS; (2) there will be no interruption of or impact on their service; (3) there will be no change to service rates, terms or conditions of service or telephone numbers; (4) there will be no charges associated with their change to GCLS as their local retail carrier; (4) they have the option to select a different service provider if they prefer. The notification also includes the toll free number which customers may call for more information. A copy of the planned customer notification is attached as Exhibit A.

Petitioners respectfully request that the Commission issue an order granting a waiver of Rule 25-24.118 in order to consummate the transfer of customers. In support of this request, Petitioners provide the following information:

I. THE PETITIONERS

GCTM was incorporated under the laws of the State of Wisconsin on October 14, 1982. Its principal office is located in New York. The company was originally authorized to provide local exchange service in Docket 971274-TX on January 13, 1998. GCTM is a wholly owned indirect subsidiary of Global Crossing Limited, a publicly traded (NASDAQ: GLBC) Bermuda corporation with affiliates in the United States and several other countries providing telecommunications services. GCTM provides local exchange service on a resold basis to approximately 81 business accounts in Florida.

GCLS was incorporated under the laws of the State of Michigan on January 4, 1995. Its principal office is located in New York. The Company was originally authorized to provide local exchange service in Docket 971598-TX on February 7, 1998. GCLS currently offers local exchange service primarily to small and medium-sized business customers. GCLS is also a wholly owned indirect subsidiary of Global Crossing Limited.

III. REQUEST FOR RULE WAIVER

Pursuant to Rule 25-24.118(1), Florida Administrative Code, the provider of a customer shall not be changed without the customer's authorization. Rule 25-24.118-(2) provides that a local provider or IXC shall submit a change request to the local exchange carrier only if one of the following has occurred: (a) the provider has a letter of agency from the customer requesting the change; (b) the provider has received a customer-initiated call for service; or (c) a third party firm has verified the customer's requested change. Because of the planned merger described above, the Petitioners ask the Commission to waive the conditions in 25-24.118-(2) in order to allow the transfer of customers of record to GCLS.

IV. CUSTOMER IMPACT

The transition to GCLS will be transparent to the affected customers. There will be no changes to rates, terms or conditions of service and customer service contact information will remain the same. Most customers have individual account executives assigned to their account and there is no plan to make any changes to this arrangement. Finally, GCTM's customers will not incur any charges as a result of the change in service provider from GCTM to GCLS.

V. PUBLIC INTEREST CONSIDERATIONS

The proposed merger is an internal corporate reorganization that will reduce costs and provide enhanced operational and economic efficiencies for the surviving Global Crossing entities. Although there will be no immediate changes to customer rates, terms and conditions of service as a result of the merger, the savings associated with this internal corporate reorganization will provide greater opportunities to improve the price performance of services available to its customers. Consequently, granting this Application is consistent with the public interest.

WHEREFORE, for the reasons stated above, the Petitioners submit that the public interest, convenience and necessity would be furthered by a grant of this Joint Petition for Waiver of Rule 25-24.118.


