Dear Ms. Cole:

Docket No. 080271-EI was opened to monitor the status of joint ownership discussions associated with Florida Power & Light's ("FPL's") Turkey Point Units 6 & 7, as directed in Order No. PSC-08-0237-FOF-EI, issued April 11, 2008.

By Order No. PSC-08-0237-FOF-EI, the Commission approved a stipulation which states in relevant part: "No later than July 1, 2009, FPL will continue its good faith discussions with FMEA, FMPA, and OUC, and will also commence good faith discussions of joint participation in Turkey Point Units 6 & 7 with JEA and Seminole. FPL will report the status of such ongoing status discussions to the FPSC every quarter thereafter."

As required by Order No. PSC-08-0237-FOF-EI, FPL has continued good faith discussions with the Florida Municipal Energy Association ("FMEA"), Florida Municipal Power Agency ("FMPA"), Orlando Utilities Commission ("OUC"), JEA and Seminole Electric Cooperative, Inc. ("Seminole").

FPL held a meeting on May 21, 2010 in Orlando, Florida at FMPA headquarters. Representatives from FMEA, FMPA, OUC, JEA, Seminole, Ocala Electric Cooperative and Lakeland Electric attended. FPL provided a project status presentation, answered questions about the project, and discussed with the participants different forms of project participation in general. Given the revised project schedule, it was determined that no significant contractual discussions were warranted at this time.
