FLORIDA PUBLIC UTILITIES COMPANY'S PETITION FOR APPROVAL OF FUEL ADJUSTMENT AND PURCHASED POWER COST RECOVERY ESTIMATED/ACTUAL TRUE-UP AMOUNT

Florida Public Utilities Company (FPUC or Company), by and through its undersigned counsel, hereby files this Petition asking the Florida Public Service Commission (FPSC or Commission) for approval of FPUC's fuel adjustment and purchased power cost recovery estimated true-up amount for the period January 2010 through December 2010. In support of this request, the Company hereby states:

3) Consistent with the requirements for this proceeding, the Company has prefiled the fuel adjustment and purchased power cost recovery true-up forms supplied by the Commission consistent with the requirements for such filings.

- 4) In accordance with Order No. PSC-10-0154-PCO-EI, issued March 18, 2010, in this Docket, the Company is also submitting, contemporaneously with this Petition, the Direct Testimony and Exhibit CDY-1 of Mr. Curtis Young in support of the Company's request for approval of the requested true-up amount.
- 5) The final true-up amounts for the period January 2009 through December 2009 are an under-recovery of \$1,378,165 for the Marianna Division, and an over-recovery of \$2,241,870 for the Fernandina Beach Division.
- 6) The estimated true-up amounts for the period January 2010 through December 2010 are an under-recovery of \$84,888 for the Marianna Division, and an over-recovery of \$172,092 for the Fernandina Beach Division.
- 7) The Company's total true-up amounts that would be collected or refunded during the period January 2011 through December 2011 are an under-recovery of \$1,463,053 for the Marianna Division, and an over-recovery of \$2,413,962 for the Fernandina Beach Division.

WHEREFORE, FPUC respectfully requests that the Commission approve the

estimated true-up amounts for January 2010 through December 2010.
