**PROGRESS ENERGY FLORIDA'S NOTICE OF PARTIAL WITHDRAWAL OF ITS
SIXTH NOTICE OF INTENT TO SEEK CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida, Inc., ("PEF" or the "Company"), files its notice of partial withdrawal of its Sixth Notice of Intent to Request Confidential Classification (the "Notice"), filed with the Commission on August, 3, 2010 and states:

Upon further review, and in consideration of the passage of time, PEF agrees to partially withdraw its Notice and not to seek confidential classification of the Company's response to Staff's Seventh Set of Interrogatories (Nos. 26-28), specifically number 28. It is PEF's understanding that this agreement resolves any objections regarding the confidentiality of the information designated as confidential in the Notice. PEF reiterates its intent to file a request for confidential classification regarding the remaining information outlined in the Notice, i.e., certain documents produced in response to Staff's Fourth Request for Production of Documents (Nos. 10-21), specifically numbers 11, 13 and 21, and nothing contained in this partial withdrawal should be construed as waiving the Company's right to seek the continued confidentiality of those documents.
