Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code., Gulf Power Company (Gulf) requests confidential classification of certain highlighted information on documents responsive to No. 6 of staff's 2nd request for PODs and No. 46(d) of staff's 7th set of interrogatories.

Staff has reviewed Gulf's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093 Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 07982-10 be approved.
