



Florida Power & Light Company (FPL) has requested approval to recover the costs associated with a turbine upgrade to the Scherer Unit 4 coal generating facility through either the Environmental Cost Recovery Clause (ECRC) or the Fuel Cost Recovery Clause (Fuel Clause). FPL asserts that with the installation of a new high pressure rotor to the Unit 4 turbine-generator, the plant will be able to generate approximately 35 MW of additional electricity output, which, in turn, will substantially offset the parasitic load imposed by the plant's environmental equipment that is being installed to comply with the Environmental Protection Agency's (EPA) Clean Air Interstate Rule (CAIR) and the Georgia Multipollutant Rule. The environmental equipment to be installed at Unit 4 includes a baghouse, a scrubber, and a selective catalytic
