The Florida Public Service Commission will consider at its December 14, 2010, Commission Conference, Docket No. 100444-GU, Application by Chesapeake Utilities Corporation (Chesapeake or Company) for Authorization to Issue Common Stock, Preferred Stock, and Secured and/or Unsecured Debt, to Enter into Agreements for Interest N Swap Products, Equity Products and other Financial Derivatives, and to Exceed Limitation Placed on Short-Nerm Borrowings in 2011.
