I am writing to describe the discussions I, on behalf of CGM, LLC ("CGM"), had with the Florida Public Service Commission regarding ATMS and related entities. During its normal course of business, CGM performs ongoing analysis and testing on the business practices of various telecommunications providers. In addition, CGM maintains regular communication with regulatory agencies, including the Florida PSC. During the course of CGM's analysis, which included reviewing publicly available information and discussing what CGM understood to be ATMS's practices with other parties, CGM was invited to discuss these matters with the Florida PSC, and I participated in a meeting with a member of the Florida PSC staff, describing what CGM had learned as specifically as I could. I do not have direct, personal knowledge of what I described.
