CHAIRMAN GRAHAM: Item Number 18.

MS. BRUCE: Commissioners, Sonica Bruce on behalf of Commission Staff.

Item Number 18, Staff's recommendation is a request for approval of tariff amendment to include a late fee of \$14 in Polk County. Staff is prepared to answer any questions that you may have at this time.

CHAIRMAN GRAHAM: Commissioner Skop.

COMMISSIONER SKOP: Thank you.

Just one question. Again, I know this is a suspend to give Staff more time to go investigate. That's all well and good. But, you know, when I'm reading this yesterday evening, a late fee of \$14, I've been here almost four years, I don't seem to remember one that high. And as a component as a percentage of total bill, I would hope Staff would take a detailed look at that. I, you know, would stand to be corrected, if I'm wrong, but \$14 seems to be almost shocking the conscience.

But, again, I'll let Staff do its own thing. And I won't be here, I don't think, to see this one again, but I felt compelled to opine as to

the magnitude of the late fee in relation to what the average bill may be for the customers, and I don't have transparency of that here. But I would just encourage Staff to take a very diligent and thorough look at what is fair, just and reasonable pursuant to statutes.

MS. BRUCE: Commissioner, I have taken some time. I wanted to contact the representative, Mike Smallridge, just to let him know I had some time just, just to be fair to look at the cost justification. And you are correct, it really is high.

From speaking with him, I think -- rather most companies base their justification on a monthly charge. I think he did it on an annual, yearly charge. He does understand that this \$14 is really high, and we intend to bring it down together. So I'm preparing a letter. I've spoken with him in regards to my concerns, and I'm preparing a letter to send out to him. So I promise you, it'll go down.

COMMISSIONER SKOP: I want Staff to exercise its own independent judgment. But, Ms. Bruce, I appreciate all your hard work and efforts on this, and just continue to ask the right questions. I appreciate it.
