## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING APPOINTMENT OF ADVISORY COMMITTEE MEMBER

## BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

The Telecommunications Access System Act of 1991 (TASA), Section 427.701, Florida Statutes, established a statewide telecommunications relay system. This system provides telecommunications service for hearing impaired persons functionally equivalent to the service provided to hearing persons.

Section 427.706, Florida Statutes, provides for up to 10 members of an advisory committee that assists this Commission with the implementation of the relay system.

We are vested with authority in this matter under Chapter 427, Florida Statute.

Presently, there are only seven active members on the TASA Advisory Committee. Many of the suggested organizations listed in Sec. 427.706, Florida Statutes, from which the Commission may select members, are no longer in existence. Having a member from the Florida Coordinating Counsel for the Deaf and Hard of Hearing (FCCDHH) serve on the Advisory Committee will provide additional input from the deaf, hard-of-hearing and late-deafness citizens of Florida. Mr. Chris Littlewood was recommended by FCCDHH to serve on the TASA Advisory Committee.
