MOTION FOR EXTENSION OF TIME

Verizon Florida LLC ("Verizon") files this motion requesting that the filing date for the parties' interconnection agreement be extended from January 17, 2011 to February 16, 2011. In support of this motion, Verizon states the following:

1. The Commission's December 3, 2010 Order in this docket ("Order") directed the parties to file a signed final interconnection agreement within 45 days of the Order, making the deadline January 17, 2011.

2. Verizon and Bright House Networks Information Services (Florida) LLC ("Bright House") have not completed their negotiations to incorporate the Commission's rulings in the Order into their final agreement. The parties believe they can complete those negotiations and file a signed final interconnection agreement by February 16, 2011.

3. Bright House consents to this motion.

WHEREFORE, Verizon respectfully requests the Commission to approve its request to extend the filing date for the signed final interconnection agreement to February 16, 2011.
