On January 11, 2011, the Florida Public Service Commission (Commission) approved Florida Power & Light Company's (FPL) proposed solar pilot programs as a part of Docket No. 100155-EG. By this letter, the Commission's staff requests that FPL file detailed program participation standards for the approved pilot solar programs within 30 days of the issuance of the Commission's order approving the programs in Docket No. 100155-EG.

The program standards should clearly state the requirements for participation in the solar pilot programs, customer eligibility requirements, details on how rebates or incentives will be processed, technical specifications on equipment eligibility, and necessary reporting requirements. The Commission's staff intends to review the standards to determine if they conform to the description of the programs contained in FPL's demand-side management plan.
