MOTION FOR EXTENSION OF TIME

Verizon Florida LLC ("Verizon") files this motion requesting that the filing date for the parties' interconnection agreement be extended from February 16, 2011 to March 18, 2011. In support of this motion, Verizon states the following:

1. The Commission's December 3, 2010 Order in this docket ("Order") directed the parties to file a signed final interconnection agreement within 45 days of the Order, making the deadline January 17, 2011. By Order dated January 24, 2011, the Commission extended the deadline to February 16, 2011.

2. Verizon and Bright House Networks Information Services (Florida) LLC ("Bright House") have made significant progress in incorporating the Commission's rulings in the Order into their final agreement, but have not completed their negotiations. They believe they can resolve the outstanding issues and file a signed final interconnection agreement by March 18, 2011.

3. Bright House consents to this motion.

WHEREFORE, Verizon respectfully requests that the Commission approve its motion to extend the filing date for the signed final interconnection agreement to March 18, 2011.
