On February 23, 2011, Florida City Gas (FCG) filed its request for confidential classification for Document No. 01210-11. The document is FCG's response to Miami-Dade County Water and Sewer Department's Second Request for Production of Documents, Item No. 19. This document is a Master Service Agreement between FCG's parent company AGL Resources and its outside regulatory consultants. Staff has reviewed the document and concurs with FCG that the nature of the information meets the requirements set forth in Section 366.093(3)(d), Florida Statutes, whereby disclosure of the information would harm AGL Resources' regulated and non-regulated business operations in multiple states including Florida.

Therefore, staff recommends that FCG's request for confidential classification of Docket No. 01210-11 be approved.
