Robert,

I went out to Tymber Creek this morning. I was on-site by 8:30 and found no detectable odors from the sewer plant or the main lift station. However, I did speak with a resident who lives adjacent to the plant and she stated odors are a frequent occurrence from the sewer treatment plant and have been for years. She has complained to the HOA in the past but has never reported it to DEP. According to her the odors happen at the usual times, first thing in the morning around 7 and then again in the evening, 7-ish as well. The odors were described as strong enough to choke and necessitated keeping the windows closed during those times. I did leave her with my card so that we can try and start keeping track of this. If you need one of us to actually physically confirm the odors please let me know and we'll see what we can arrange, it's about an hour and twenty minutes from the office to Tymber Creek but we have an inspector that lives in that county so she might be willing to pop up there early one morning.

HI, Robert,

I got your message and will be glad to call you back, but I really don't have much information about problems with odors, and it has not been specifically addressed in our permit. I asked our compliance staff if they knew about odor complaints. According to Daniel Hall, "the only odor issues have been related to the numerous overflows from the lift station." I told one of the folks I talked to after the meeting that the upgrades to the LS will likely correct the problem we were discussing at the time. If septic conditions are forming overnight and causing the morning odors when the flows increase, the utility might need to install odor controls of some kind. If it is actually the WWTF, not the LS, they are complaining about it is not a problem that has been brought to our attention.
