Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code., Florida Power & Light Company (FPL) requests confidential classification of certain highlighted information describing the warranty that applies to the ESP for the 800 MW oil-fired units responsive to staff's request at the 3/29/11 informal meeting.

Staff has reviewed FPL's confidentiality request. In staff's opinion, the request does meet the criteria for confidentiality contained in Section 366.093 Florida Statutes. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 02773-11 be approved.
