**SECTION 63.71 APPLICATION OF BELLSOUTH TELECOMMUNICATIONS, INC.
D/B/A AT&T SOUTHEAST**

AT&T Inc. on behalf of its affiliate, BellSouth Telecommunications, Inc. d/b/a AT&T Southeast, (herein after "AT&T") applies for authority under Section 214(a) of the Communications Act, as amended ("the Act"), 47 U.S.C. § 214 and Section 63.71 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. § 63.71, to discontinue offering Modular Video Transport (MVTs) and Commercial Quality Video (CQVS) services throughout their service territories in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

As required by Section 63.71(a) and (b) of the Commission's rules, AT&T is providing the following information:

Date of Planned Service Discontinuance (47 C.F.R. §§ 63.71(a)(2), (b)(2)):

AT&T plans to discontinue offering MVTS and CQVS to new customers effective August 1, 2011, subject to Commission approval of this application. CQVS will continue to be provided to existing customers on a month-to-month basis until the service is withdrawn on or after August 1, 2012, subject to approval of this application. MVTS will continue to be provided to existing customers until their current agreements expire or on a month-to-month basis and will be discontinued by AT&T on or after December 31, 2014 with 30 days advanced notice, subject to approval of this application.

Points of Geographic Areas of Service Affected (47 C.F.R. §§ 63.71(a)(3), (b)(2)):

MVTS and CQVS will be discontinued throughout the AT&T service territories in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

Brief Description of Type of Service Affected (47 C.F.R. §§ 63.71(a)(3), (b)(2)):

Modular Video Transport Service is a fiber optic transport video service that interconnects two or more customer designated locations to provide one way video service with audio.

Commercial Quality Video Service provides a video channel with one-way transmission capability for a standard 525-line /60-field monochrome or NTSC (National Television Systems Committee) – System M video signal.

AT&T is discontinuing these services due to lack of demand. The public convenience and necessity is not harmed by AT&T's discontinuance of these services as there are competing advanced video transport services in the marketplace including AT&T's Broadcast Quality Video service and Serial Component Video service.

Brief Description of the Dates and Methods of Notice to All Affected Customers (47 C.F.R.

§ 63.71(b)(3)):

AT&T notified its customers of its intention to discontinue offering these services by letters sent via U.S. Mail on May 13, 2011. A copy of the customer notifications are attached.

Copies of this Application are being sent, first class U.S. Mail, to the public utilities commissions and governors of each state in which discontinuance is proposed and also to the Special Assistant for Telecommunications to the Secretary of Defense, as required by Section 63.71(a) of the Commission's rules.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

AT&T acknowledges that this Application will be processed using the Commission's rules for dominant carriers.

Thank you for using AT&T for your communication service needs. We want to be sure you are kept aware of upcoming changes to your Modular Video Transport Service.

Triggered by a market evolving to digital transport video offerings, **AT&T is notifying you that Modular Video Transport Service will be withdrawn on December 31, 2014, and we wish to provide notice of our transition plans. This will provide time for you to review the alternative services that are available to you.**

Effective on or about August 1, 2011, pending regulatory approval, Modular Video Transport Service will no longer be available to new customers in Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee (no current contract or service), and existing customers will not be permitted to purchase new service.

As a current AT&T customer with Modular Video Transport Service, you may retain your existing service(s), until the service is discontinued, subject to the following service restrictions:

- **Effective August 1, 2011, AT&T will no longer renew service agreements for Modular Video Transport Service.**
- **Effective August 1, 2011, Moves, Additions, and Change orders for Modular Video Transport Service will no longer be accepted.** Beginning August 1, 2011, new requests for physical changes to Modular Video Transport Service, including the installation of new service or moves to different service addresses will not be provisioned.

Existing customers may continue to use their Modular Video Service in accordance with the terms of their agreement for service, until such agreements expire. Following the expiration of an existing Modular Video Transport Service term agreement, AT&T will continue to provide Modular Video Transport Service on a month-to-month basis until the service is withdrawn. During any month-to-month service period, AT&T may change the rates, terms and conditions of the service upon at least 30 days notice.

Although AT&T plans to discontinue Modular Video Transport Service, **AT&T offers as a replacement Serial Component Video Service and Broadcast Quality Video Service (TV1).**

and Television Engineers standard 259M). The bandwidth is 270 Mbps. SCVS is becoming the service of choice for broadcasters transitioning from an analog to digital transmission format for digital TV and High Definition broadcasting.

If you still require an NTSC quality video signal, AT&T's TV1 service provides an excellent broadcast access solution. AT&T's TV1 service is a point-to-point, one-way video service for the transmission of a National Television Standards Committee (NTSC) color video signal. The bandwidth is from 30 Hz up to 6.6 MHz.
