To the Executive Secretary of State of the Public Utilities Commission:

DelTel, Inc. ("DelTel") requests that the Florida Public Service Commission ("Commission") cancel its authority granted by, and rescind all tariffs on file with, the Commission to provide Interexchange Telecommunications Services, effective immediately.

In Florida, DelTel is authorized by the Commission to provide Interexchange Telecommunications Services pursuant to Docket No. 030963-TI, issued on 10/3/2003. Due to natural attrition, DelTel, Inc. no longer has Interexchange Telecommunications Customers in Florida and therefore, no longer requires its authorizations. Because DelTel does no longer serves any telecommunication customers in Florida and neither holds deposits nor advance payments from any Florida consumers, DelTel respectfully submits that the surrender of its authorizations and withdrawal of its tariffs is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.


