On behalf of Aqua Utilities Florida, Inc. 6. **Proof of ownership**. Pursuant to Rules 25-30.033(1)(j) and 25-30.036(3)(d), F.A.C., evidence is required that the utility owns, or has long-term access to, the land upon which the utility treatment facilities are located. Although, the certification and transfer of the wastewater system is pending Commission approval, please provide an executed copy of the document intended to convey the continued use of the land under

the wastewater treatment facilities from the seller to the buyer. In addition, the legal description shown in Exhibit F to the wastewater application does not appear to describe the land under the wastewater treatment facilities, as it is identical to the legal description provided for the water treatment facilities.

RESPONSE:

The requested proof of ownership for the Harbor Hills Utilities L.P.'s wastewater land is appended as Attachment "2". AUF is in the process of gathering and reviewing the appropriate unexecuted closing documents requested. This data will be provided at a later date, once the documents have been gathered and reviewed.

Additional Information

7. Wastewater Revenue Requirements. Please describe in detail the basis used and/or documents relied upon for the annual wastewater growth projections through the year 2014.

RESPONSE:

The wastewater growth projections are based on data received from the current utility owner, who is also the developer for the service area. The current owner/developer indicated that there is additional territory inside the current development of 88 future homes for water/sewer service. For the projections, it was assumed these 88 additional new homes (connections) would occur over the next seven years. The proposed initial rates were calculated at 80% build out in year six.

8. System Maps. Please provide water and wastewater system maps showing which lots have existing connections and which lots are vacant.

RESPONSE:

The requested system maps indicating the lots and existing connections are appended hereto as Composite Attachment "3".






