Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Progress Energy Florida (PEF) requested confidential classification of certain highlighted information that was included in its response to interrogatories and production of documents from Docket No. 110009-EI.
