Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Progress Energy Florida requests confidential classification of certain highlighted information provided in response to staff's First Request For Production of Documents (PODs 1-13). The entire responses to PODs 1-4, 6, and 13 are confidential, whereas the responses to PODs 5 and 7-12 are partially confidential. The responses were filed on 5/23/2011.

Staff has reviewed Progress Energy Florida's confidentiality request. In staff's opinion, the requests meet the criteria for confidentiality contained in Section 366.093, Florida Statutes. Therefore, staff recommends that the requests for confidentiality of certain information included in Document No. 03597-11 be approved.
