## WAIVER REQUEST

Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications ("Birch" or "Purchaser") hereby requests a waiver from the Florida Public Service Commission ("Commission") of Rule 25-4.118, Florida Administrative Code, and any other regulations deemed applicable to the authorization and verification of changes in telecommunications providers ("Waiver Request"). This Waiver Request is made in connection with a transaction in which Birch will acquire substantially all of the telecommunications assets and Florida customers ("Transaction") of Cordia Communications Corp. ("Cordia" or "Seller") (Birch and Cordia collectively, the "Parties"). Birch submits the following in support of this Waiver Request:

#### I. **DESCRIPTION OF THE PARTIES**

#### Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Α. **Communications**

Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications is a Delaware corporation with headquarters located at 3060 Peachtree Road NW, Suite 1065, Atlanta, Georgia. Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications is authorized by the Commission to provide local exchange and interexchange

services in Florida.<sup>1</sup> Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications is a wholly owned subsidiary of Birch Communications, Inc. ("BCI"), which is a Georgia corporation with principal corporate offices located at 3060 Peachtree Road NW, Suite 1065, Atlanta, Georgia. Birch Communications, Inc. is authorized by the Commission to provide local exchange and interexchange services in Florida.<sup>2</sup> The customers to be acquired in the Transaction will be served by Birch Telecom of the South, Inc. dba Birch Telecom dba Birch Communications.

## B. Cordia Communications Corp.

Cordia is a Nevada corporation with headquarters located at 2900 Westchester Avenue,

### **III. REQUEST FOR WAIVER**

Pursuant to Rule 25-4.118, Florida Administrative Code, a customer's local exchange or interexchange telecommunications service provider shall not be changed without the customer's authorization. To make such a change, the carrier must either: (1) obtain a letter of agency from the customer requesting the change; (2) obtain confirmation from the subscriber via a customer-initiated call; or (3) utilize an independent third party to verify the subscriber's order. The requirements of Rule 25-4.118 are applicable to interexchange carriers through incorporation by reference in Rule 25-24.490.

Birch respectfully requests a waiver of Rule 25-4.118 so that Cordia may transfer to Birch its customer accounts in Florida without Birch securing authorization and verification from each of Cordia's customers in Florida. Obtaining the authorization and verification from each of the affected customers would be a burdensome process and impose an undue hardship on Birch. This transfer of customers will result from a transaction whereby Birch will acquire substantially all of the telecommunications assets and Florida customers of Cordia pursuant to an Asset Purchase Agreement ("Agreement"). On June 17, 2011, BCI submitted a proposal, including the Agreement, to the United States Bankruptcy Court for the Middle District of Florida (Case No. 6:11-bk-06493-KSJ through 6:11-bk-06497-KSJ) to purchase certain assets and customers of Cordia (as well as its affiliates My Tel Co, Inc. and Northstar Telecom, Inc., which do not offer service in Florida). On June 29, 2011, BCI learned that no other entity submitted a similar proposal to the bankruptcy court, and on July 14, 2011, the bankruptcy court approved the Agreement. Pursuant to the Agreement, BCI will purchase the following assets from Cordia: customer accounts, customer agreements and contracts, certain vendor agreements and contracts, and certain intellectual property. BCI, however, will not assume any of Cordia's pre-closing liabilities.

As a result of the Transaction, Birch will provide service to Cordia's customers in Florida and Cordia will not continue to operate as a telecommunications carrier in Florida. Birch will comply with the requirements of the Federal Communications Commission ("FCC") governing the sale of a carrier's customer base as set forth in 47 C.F.R. § 64.1120(e). These rules require that every affected customer receive at least thirty (30) days prior written notice of the proposed transfer to Birch, and that Birch certify to the FCC that it has provided such written notice to each subscriber affected by the Transaction. A draft of the customer notice letter to be used in connection with this Transaction is attached as <u>Exhibit A</u>. Affected customers will be notified in writing of the transfer of their service to Birch and of their right to choose a different carrier pursuant to applicable FCC rules. The legal rights of affected customers, therefore, will not be prejudiced by a waiver of the Commission's rule because Birch will comply with the FCC's rules governing this type of transaction, which are specifically designed to protect the rights of customers.

Upon consummation of the Transaction and after completion of the customer transfer, Birch will provide Cordia customers with the same service quality they have come to expect and all billing will be handled by Birch. Birch will file revised tariff sheets incorporating Cordia's current services and rates so that the affected customers will continue to receive the same services that they currently receive without any immediate changes to their service offerings, rates, or terms and conditions. The transfer is scheduled to take place on or after October 13, 2011 assuming receipt of all necessary regulatory approvals.

Upon completion of the Transaction and the migration of customers to Birch, Cordia will no longer offer telecommunications services in Florida. After Cordia determines that it no longer needs its Florida authorizations for operational or billing purposes, Cordia will surrender its authorizations and cancel its tariffs in a separate filing.

### IV. PUBLIC INTEREST CONSIDERATIONS

The basis for granting a waiver for local exchange and interexchange carriers is set forth in Section 120.542, Florida Statutes, and Rule 25-24.455(4), Florida Administrative Code. Under Section 120.542 a request for waiver must demonstrate that the purpose of the underlying statute will otherwise be served if waiver of the rule is granted and that enforcement of the rule would result in substantial hardship for the petitioner or violate principles of fairness. Similarly, under Rule 25-24.455(4), the Commission may consider whether the petition is in the public interest, whether market forces obviate the need for the provision in a particular instance, and whether reasonable alternative regulatory methods may service the same purpose.

In the circumstance described in this Waiver Request, it is in the public interest to waive the carrier selection requirements of Rule 24-4.118, Florida Administrative Code. Rule 25-4.118 does not prescribe any means of authorizing a carrier change that is necessitated by a mass migration of customers as part of an asset transfer. It would be unfair to hold Birch to requirements that plainly do not address its particular situation and with which it cannot reasonably comply. Birch has provided for a seamless transition while ensuring that customers understand available choices with the least amount of disruption and confusion; thus, the requirements of the rule are satisfied. The customers will receive at least thirty (30) days notice of the transfer and be afforded the opportunity to select another carrier. If prior authorization

from each customer is required, customers may fail to respond to a request for authorization, neglect to select another carrier, and thus lose their service.

Grant of this Waiver Request will serve the public interest by ensuring that Cordia's customers enjoy continuity of high-quality telecommunications service. Following the Transaction, the customers will continue to receive quality services supported by Birch's experienced and well-qualified management team. Consequently, the proposed Transaction will be transparent to customers in terms of the rates and terms and conditions of service that these customers currently receive. The public interest therefore will be served by approval of this Waiver Request.

WHEREFORE, Birch respectfully requests that the Commission grant the request for a waiver of Rule 25-4.118 on an expedited basis and grant additional relief as may be proper and necessary under the circumstances.

## IMPORTANT NOTICE REGARDING A CHANGE IN YOUR TELECOMMUNICATIONS SERVICES

Dear

Birch Communications ("Birch") and Cordia Communications Corp. ("Cordia") are pleased to announce that Birch will acquire Cordia's local and long distance telephone customers. Subject to approval by the Federal Communications Commission and state regulators, Birch will replace Cordia as your current telecommunications service provider on or after [30 DAYS BEFORE TRANSFER DATE] (the "Transfer Date"). As a result of this transaction, Birch will assume responsibility for all services previously provided to you by Cordia. Birch is excited about the opportunity to provide your telecommunications service(s) and looks forward to a long and successful business relationship.

Please rest assured, the transition will have little or no impact on your current services, nor will there be any interruption of your service. The agreement between Birch and Cordia has been structured so that the transfer of service will be virtually seamless other than the possibility of a minor change to your voice mail service for which you will receive additional information.<sup>1</sup> There may, however, be other changes to your service plan based on Birch's unique billing systems (*e.g.*, customers currently utilizing a message or measured local service plan may be switched to a flat rate plan). In those cases, Birch will transition you in a neutral manner and *with no increase to your regular monthly recurring charges.* You will retain all other service rates, features, terms, and conditions of service and your telephone phone number. Birch will not impose any charges for the transfer of your services to Birch and **no action is required from you to continue your telecommunications service(s) with Birch**. You will receive your first billing statement from Birch starting with your [MONTH] 2011 or [MONTH] 2011 bill. As in the past, you are responsible for paying all bills rendered to you by Cordia during the transition of service.

You do have the right to select a different carrier for the telecommunications service(s) at issue. If you choose to switch to an alternate carrier for services, you may incur a fee from that alternate carrier for the transfer of services to that alternate carrier.
