PURPOSE AND EFFECT: Rule 25-4.0161 would be amended to reduce the regulatory assessment fee for telecommunications companies under s. 350.113 and 364.336, F.S., as required by s. 364.336, F.S., to remove references to company types no longer regulated by the Commission, to amend regulatory assessment fee filing forms, and to clarify requirements for requesting a filing extension.
