

### FLORIDA CITY GAS's NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

Florida City Gas ("FCG" or "Company") by and through its undersigned counsel, pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(3), Florida Administrative Code, hereby submits its Notice of Intent to Request Confidential Classification for information contained in Florida City Gas's Responses to Staff's First Data Request.

Specifically, the Company intends to request confidential classification of information contained in its response to Data Request Question No. 1, parts B and D. Information included in the response to Data Request Question No. 1, parts B and D, includes confidential contractual information as well as information that would allow confidential contractual information to be easily derived. The Company treats this information as proprietary confidential business information consistent with the definition of that term in Section 366.093, Florida Statutes.

Release of the information in the response to Data Request Question No. 1, parts B and D, as a public record would harm the Company's business operations and ratepayers by impairing the Company's ability to effectively negotiate for goods and services. As such, the Company requests that the Commission protect this information pending the Company's filing a Request for Confidential Classification consistent with Rule 25-22.006, Florida Administrative Code.
