On July 28, 2011, Equity LifeStyle Properties ("ELS") filed in this docket a motion to extend the time for submitting a Motion to Dismiss each Objection to the Proposed Utility and Petition For Formal Administrative Hearing ("Objection") filed on July 13, 2011, by, respectively, Pasco County ("County") and The City of New Port Richey ("City"). Per Rule 28-106.204(1), Florida Administrative Code, absent an extension of time, ELS's Motion to Dismiss was due on August 2, 2011.
