# AQUA UTILITIES FLORIDA, INC.'S MOTION TO COMPEL LUCY WAMBSGAN'S REPONSES TO FIRST SET OF INTERROGATORIES AND FIRST REQUEST FOR PRODUCTION OF DOCUMENTS

Aqua Utilities Florida, Inc. ("AUF" or the "Company"), by and through its undersigned counsel, respectfully files this Motion to Compel Lucy Wambsgan's Responses to AUF's First Set of Interrogatories and First Request for Production of Documents served by AUF on August 19, 2011 ("Discovery Requests"), because Ms. Wambsgan has failed to provide any response to the Discovery Requests. In support of its motion, AUF states as follows:

- 1. In this Proposed Agency Action ("PAA") rate case, AUF customer Lucy Wambsgan is represented by counsel. Ms. Wambsgan was granted intervention on April 25, 2011 and formally filed her Petition Protesting Portions of Proposed Agency Action and Requesting a Formal Proceeding on July 1, 2011.
- 2. On August 19, 2011, AUF served on Ms. Wambsgan its First Set of Interrogatories (Nos. 1-37) and First Request for Production of Documents (Nos. 1-38), which are attached as Exhibits A and B respectively. On that same date AUF filed its notice of the service of these Discovery Requests, which is attached as Exhibit C.
- 3. The Discovery Requests seek relevant, discoverable information and documents for purposes of this proceeding.

- 4. The Order Establishing Procedure issued on July 25, 2011 (the "Procedural Order"), provides that "[w]hen a discovery request is served and the respondent intends to seek clarification of any portion of the discovery request, the respondent shall request such clarification within 10 days of service of the discovery request." Order No. PSC-11-0309-PCO-WS, at 4. AUF did not receive any request from Ms. Wambsgan seeking clarification regarding the Discovery Requests.
- 5. The Procedural Order further provides that "any specific objections to a discovery request shall be made within 20 days of service of the discovery request." *Id.* Ms. Wambsgan has not served any objections to the Discovery Requests, whether in the allotted period or since.
- 6. Finally, the Procedural Order provides that "Discovery responses shall be served within 30 calendar days (inclusive of mailing) of receipt of the discovery request." *Id.* Thus, the deadline for Ms. Wambsgan's responses to the Discovery Requests was September 19, 2011.
  - 7. To this date, Ms. Wambsgan has served no responses to the Discovery Requests.
- 8. AUF is entitled to responses to its Discovery Requests, and an order to compel is appropriate. See Fla. R. Civ. P. 1.380(a)(2) ("If a ... party fails to answer an interrogatory submitted under rule 1.340, or if a party in response to a request for inspection submitted under rule 1.350 fails to respond that inspection will be permitted as requested or fails to permit inspection as requested, ... the discovering party may move for an order compelling an answer, ... or an order compelling inspection").
- 9. Moreover, Florida Rule of Civil Procedure 1.380(d) provides additional remedies where a party "fails ... to serve answers or objections to interrogatories submitted under rule 1.340 after proper service of the interrogatories, or ... to serve a written response to a request for inspection submitted under rule 1.350 after proper service of the request." In such instances, the

Rule authorizes specified relief including "[a]n order that the matters regarding which the questions were asked or any other designated facts shall be taken to be established for the purposes of the action in accordance with the claim of the party obtaining the order, ... [a]n order refusing to allow the disobedient party to support or oppose designated claims or defenses, or prohibiting that party from introducing designated matters in evidence, [or] [a]n order striking out pleadings or parts of them or staying further proceedings until the order is obeyed, or dismissing the action or proceeding or any part of it, or rendering a judgment by default against the disobedient party."

- 10. It should be noted that Ms. Wambsgan has waived any objections to the Discovery Requests by failing to make any specific, timely objections. As provided in Rule 1.380(d), "[t]he failure to act described in this subdivision may not be excused on the ground that the discovery sought is objectionable unless the party failing to act has applied for a protective order as provided by rule 1.280(c)." Moreover, the express purpose of the advance objection provision in the Procedural Order is "to reduce delay in resolving discovery disputes." Order No. PSC-11-0309-PCO-WS, at 4. Objections at this late date would completely contravene the purpose of that provision, and should not be allowed.
- Procedure, and the Order Modifying the Order Established Procedure issued on September 13, 2011, undersigned counsel for AUF certifies that he has conferred in good faith with counsel for Ms. Wambsgan for purposes of resolving this issue without Commission intervention. As reflected in the e-mail to counsel for Ms. Wambsgan dated September 26, 2011 (Exhibit D), the undersigned agreed to refrain from filing a motion to compel if Ms. Wambsgan provided the information responsive to the Discovery Requests by close of business on September 30, 2011.

To date, Ms. Wambsgan has served no responses to the Discovery Requests and such responses are over 15 days past due.

## Conclusion

For the reasons set forth above, AUF respectfully requests that the Commission compel Lucy Wambsgan's responses to AUF's First Set of Interrogatories and First Request for Production of Documents, and to require that Ms. Wambsgan not limit such responses in reliance on any objection, since Ms. Wambsgan has waived her objections.
