After I have purchased Sunrise Utilities and not being experienced at this field realized, the initial capital invested was not enough to make the business function, and it became an absolute must to inject more money with loans.

In today world there are no more smaller business, just major capitalist in every field, from clothing to the food chains and when they are in control, THEY dictate the price.

I can see the trend to continue in the water business also. If not protecting the smaller operators for the benefit of a reasonable rate to their customers, will allow the major players at that field to take over, the end result will be a much higher rate for Sunrise customers than we are asking for.

In an other scenario looking through your web site, I have noticed when business failed the County interject or hire an individual experienced at this field and this person becomes the new owner after the bank loans or any other added expense are paid back.
