On September 28, 2010, Tradewinds Utilities, Inc. (the "Utility"), completed its application the Florida Public Service Commission (the "Commission") for increased water and wastewater rates, in which it requested a permanent increase for its water system in Marion County of 67,80% and an increase for its wastewater system in Marion County of 17.49%.

By Proposed Agency Action Order No. PSC-11-0385-PAA-WU ("PAA"), issued September 13, 2011, the Commission approved a rate increase of 57.50% for water service and 1.32% for wastewater service. In addition, the Commission approved revised miscellaneous service charges. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent cost for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water service. The PAA Order was not protested within the protest period, and became final by Order No. PSC-11-0488-CO-WU, issued October 7, 2011.

The increased rates and charges are effective for services on or after October 14, 2011.

The rates prior to filing, the Commission-approved water rates and approved revised miscellaneous service charges are attached to this customer notice.

The notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its Customers.
