DOCUMENTS REQUESTED

The witness should bring documents reflecting calculations of all the fuel factors based on the demand allocation methodology that was used in prior filings, i.e., using Gulf's and FPL's most recent load research data to allocate demand costs to the various rate classes, specifically, revised Schedules E1, E10, and Schedule CCE-2, page 1 of 2, Column A, for both the Northwest and Northeast Divisions. For the Northwest Division, the fuel factors would reflect a demand cost allocation to the rate classes based on Gulf's most recent load research data (which are shown in Gulf's 2012 projection filing for its capacity cost recovery factors, Schedule CCE-2, page 1 of 2, Column A). For the Northeast Division, the fuel factors would reflect a demand allocation to the rate classes based on FPL's most recent load research data (which FPL used in its 2012 capacity cost recovery projection filing).

This deposition is being taken for purposes of discovery, for use at trial, or for any other purpose allowed under the Florida Rules of Civil Procedure, the Uniform Rules of Procedure, and the Rules of the Florida Public Service Commission.


