Clarification/additional information from AT&T: The RFP states:
"As a part of the bidder's proposal, the transmittal letter should be followed by the evaluation checklist in Section E. In the blank beside each item on the checklist, the company contact person who is responsible for the proposal and any subsequent contract and who signs the transmittal letter should initial (not check) each item in the check list which is contained within the proposal. The person initialing the checklist should ensure that each item in the checklist is also contained in its proposal and in the same order as the item appears in the checklist. The bidder should also indicate beside each item in the checklist the page number in its proposal where the item in the checklist can be found." Our senior vice president will be signing the transmittal letter. However, as the AT&T contact person for the RFP proposal responsible for the development of its contents, may I initial off on the checklist items since I'm developing the response and will know the location of all sections/responses?
