Rule 25-6.065(5)(d) addresses the requirements that a Standard Interconnection Agreement contain a provision that the customer hold harmless and indemnify the investor-owned utility for all loss to third parties resulting from the operation of the customer-owned renewable generation, except when the loss occurs due to the negligent actions of the investor-owned utility. Rule 25-6.065(5)(e) addresses the requirement that a Standard Interconnection Agreement contain general liability insurance for personal and property damage, or sufficient guarantee and proof of self-insurance, in the amound of no more than \$1 million for Tier 2 customers and no more than \$2 million for Tier 3 customers.
